## Terms and Conditions – Trade Credit

#### Application of these conditions

These conditions apply to any extension of credit by Baseline Group (Personnel) Pty Ltd and/or its subsidiaries. ("Baseline Group (Personnel) Pty Ltd") to the Applicant whose details are set out in the "Details of Applicant" ("the client"). Baseline Group (Personnel) Pty Ltd will not be bound by any additional or conflicting conditions including but not limited to conditions contained in any Purchase Order unless they are accepted in writing by a Baseline Group (Personnel) Pty Ltd Director.

### Payment Terms

Invoices are rendered weekly with any accompanying timesheets. Client will be charged as per timesheet that has been duly authorized by a company representative. These are substantially for wages which are paid each week by Baseline Group (Personnel) Pty Ltd. All invoices are therefore payable within 14 days from the date of the invoice, or within such longer period as is agreed in writing by a Baseline Group (Personnel) Pty Ltd Director.

#### **Claims for Credit**

Any queries in relation to an invoice must be notified to Baseline Group (Personnel) Pty Ltd within three (3) days of the client's receipt of invoice, failing which, the invoice is considered accepted and must be paid in full by the due date without deduction. The client will use its best efforts and provide all necessary information and co-operation to enable any legitimate queries relating to any invoice to be resolved promptly. Nothing in this condition affects Baseline Group (Personnel) Pty Ltd's entitlement to be paid the full amount properly due to it and any applicable late settlement fee.

#### **Right to Withdraw Credit**

Baseline Group (Personnel) Pty Ltd may withdraw any extension of credit to the client at any time at Baseline Group (Personnel) Pty Ltd's discretion.

#### **Conditions of Labour Hire**

All services provided by Baseline Group (Personnel) Pty Ltd to the client are provided upon and are subject to Baseline Group (Personnel) Pty Ltd's termsn and conditions (as amended by Baseline Group (Personnel) Pty Ltd from time to time), the current version of which is located on our website at <u>www.baselinegroup.com.au</u>. By submitting this application the client expressly accepts and agrees to be bound by such terms and conditions.

#### Jurisdiction

The applicable law to this application (and the conditions contained in it) is that of the State of Western Australia or at Baseline Group (Personnel) Pty Ltd's option that of the state or Territory of the Commonwealth of Australia in which the relevant services are being provided by Baseline Group (Personnel) Pty Ltd to the client.
